# COLLECTION AND USE OF PERSONAL INFORMATION

**Create an Account:** You do not have to create an account to visit our Website, however you will be required to create an account in order to access the ResVR Portal. We will never ask you for your password in any unsolicited communication (such as letters, phone calls or email messages).

**ResVR Portal:** If you are a home buyer, when you use the ResVR Portal you can access, download or upload pictures and other documents related to your new home and the specific floor plans and related documentation. If you are a builder, you can provide a link to your customers to access the ResVR Portal to view certain pictures or documents related to the construction they are interested in. In order to access the ResVR Portal, you will be required to create an account.

**Marketing Communications:** If you sign up to receive email marketing communications, we will collect your email address in order to send you newsletters, offers and promotions. You can unsubscribe at any time by clicking the "unsubscribe" link included at the bottom of each email. Alternatively, you can opt-out of receiving email marketing communications by contacting us at the contact information provided in the "Contact Us" section below. Please note that you may continue to receive transactional or account-related communications from us.

**Employment:** In connection with a job application or related inquiry, you may provide us with certain personal information about yourself (such as that contained in a resume, cover letter, or similar employment-related materials). We use this information for the purpose of processing and responding to your application for current and future career opportunities.

**Surveys:** From time to time, we may offer you the opportunity to participate in one of our surveys. The information obtained through our surveys is used in an aggregated, de-identified form. We use this information to help us understand our users and to enhance our Website.

**Contact Us:** When you contact us with a comment, question or complaint through email or telephone, you may be asked for information that identifies you, such as your name, address and a telephone number, along with additional information we need to help us promptly answer your question or respond to your comment. **Legal and Compliance:** We and our Canadian, U.S. and other foreign service providers may disclose your personal information in response to a search warrant or other legally valid inquiry or order, or to another organization for the purposes of investigating a breach of an agreement or contravention of law or detecting, suppressing or preventing fraud, or as otherwise may be required or permitted by applicable Canadian, U.S. or other law or legal process, which may include lawful access by U.S. or foreign courts, law enforcement or other government authorities. Your personal information may also be disclosed where necessary for the establishment, exercise or defence of legal claims and to investigate or prevent actual or suspected loss or harm to persons or property.

**Sale of Business:** We may transfer any information we have about you as an asset in connection with a proposed or completed merger, acquisition or sale (including transfers made as part of insolvency or bankruptcy proceedings) involving all or part of ResVR or as part of a corporate reorganization or other change in corporate control.

# SAFEGUARDS AND RETENTION
